

BY-LAWS OF
Senior Center of Wiscasset, Inc.

Revised September 21, 2011

A NOT-FOR-PROFIT CORPORATION

ARTICLE I - ORGANIZATION

The name of the organization shall be Senior Center of Wiscasset, Inc. (“Corporation”)

ARTICLE II - PURPOSE

This Corporation has been formed for the following purposes:

To raise funds to finance upgrades and new equipment and furniture for the physical plant of the Wiscasset Senior Center from Wiscasset Senior Center members, area residents and businesses.

To raise funds to finance entertainment/educational events for Wiscasset Senior Center members and invited guests from the membership of the Wiscasset Senior Center, area residents and businesses.

ARTICLE III - MEETINGS

The annual meeting of the Corporation shall be set by the Board of Trustees during the month of July.

Notice of the annual meeting and of any special meeting shall be provided to any person entitled to vote by mail service at least 10 business days prior to such meeting. Unless such notice is waived by the person entitled thereto.

ARTICLE IV - BOARD OF TRUSTEES

The business of the Corporation shall be managed by a Board of Trustees consisting of the current Trustees of the Wiscasset Senior Center and shall serve until their successors are elected and qualified.

The Board of Trustees shall have the control and management of the affairs and business of the Corporation. Such Board of Trustees shall only act in the name of the Corporation when it shall be regularly convened by its chairman after due notice to all the Trustees of such meeting.

Each Trustee shall have one vote and such voting may not be done by proxy.

The Board of Trustees may make such rules and regulations covering its meetings as it may in its discretion determine necessary.

The Chairman of the Wiscasset Senior Center Trustees shall be Chairman of the corporation.

A Trustee may be removed when sufficient cause exists for such removal. The Board of Trustees may entertain charges against any Trustee. The Board of Trustees shall adopt such rules for this hearing as it may in its discretion consider necessary for the best interests of the Corporation.

ARTICLE V - OFFICERS

The officers of the Corporation shall be the officers of the Board of Trustees of the Wiscasset Senior Center, consisting of a Chairman, Vice Chairman, Secretary and Treasurer, and shall hold such offices until their successors are appointed and qualified.

ARTICLE VI - SALARIES

The Board of Trustees and the Officers of the Corporation shall serve without compensation.

There shall be no hired staff.

ARTICLE VII - COMMITTEES

The Board of Trustees shall appoint all committees of the Corporation. The term of office for such committees shall be for an indeterminate period or less if terminated by the action of the Board of Trustees.

ARTICLE VIII - AMENDMENTS

Any amendments to these By-Laws shall be accomplished by an affirmative vote of not less than two-thirds of the then current Board of Trustees.

Revision History

**The following is a summary of the significant changes made to these by-laws on
September 21, 2011.**

- 1) In article I, deleted reference to “trips” as part of the fund raising.
- 2) Throughout these by-laws, changed the term Director to Trustee to be consistent with the Wiscasset Senior Center by-laws.
- 3) Changed the head of the corporation from a “President” to a “Chairman” for consistency.
- 4) In article V, added Vice Chairman as an officer of the corporation to agree with the revised Wiscasset Senior Center by-laws.
